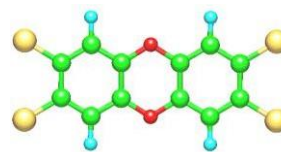

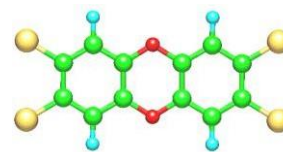

General Terms & Conditions

The DIOXIN2025 (hereinafter the “Event”) is organised by Dioxin20XX and Thor Turizm Organizasyon San Tic.Lti.Şti (hereinafter the “Organiser”) from 1 to 6 November 2025 in Antalya, Türkiye.

Thor Turizm Organizasyon San Tic.Lti.Şti (hereinafter “Thor Events”) supports the Organiser in the organisation of the event, providing the following services: Registration management, Exhibition and Sponsorship management, Event logistics.

By registering to the Event, participants (hereinafter "participant" or “participants”) are entering an agreement with Dioxin20XX and Thor Events, for which all participants are requested to read and acknowledge the Terms & Conditions set out below.

Event Secretariat

Registration & Fees

Participants are required to register via the online registration system.

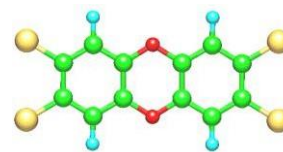
All fees (i) are in EURO (€), (ii) are the net amount due to the Organiser (all transfer costs are for the participant) and (iii) exclude the applicable VAT rate: Please note that the standard Turkish VAT rate is 20% and it will be charged on all registrations.

Methods of Payment

The online registration platform is a secured site. Major credit cards (American Express, VISA and MasterCard) are accepted. For payments by credit card, the payment confirmation is notified upon completion of the registration process. Participants will receive a confirmation email including a link to their digital invoice. The invoice will reflect the amount paid by credit card. Participants who do not receive a confirmation email should contact the Registration Secretariat at dioxin2025@thorevents.com

In case of a rejected online credit card payment, the participant is recommended to contact the credit card issuer to check if online transactions are being declined by the issuer.

Wire transfer payment will also be accepted but wire transfer fees must be paid by the participant. For payments by bank transfer, an invoice is issued upon completion of the registration process. Participants will receive a confirmation email including a link to their digital invoice. The invoice

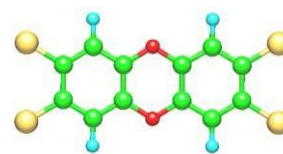
The online registration can be completed by clicking the button "submit" which can be found at the end of the form.

Should one deadline be missed, the next applicable fee will be charged automatically. The registration will only be confirmed upon receipt of payment in full.

If the maximum attendee capacity is reached, the organisers reserve the right to refuse any registration.

Only registered attendees will be permitted access to the Conference.

To be eligible to register for the Conference, attendees must be at least 18 years old. Attendees may be asked to present an official identity card stating their age.

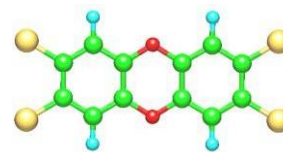

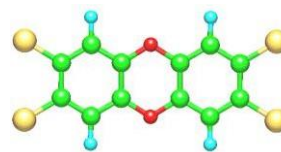

There will be no refund for badges which are paid for, but not used (according to the deadlines mentioned above).

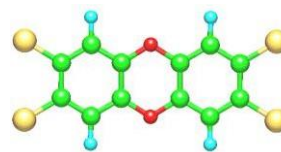

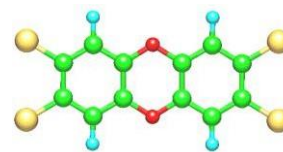
The Letter of Invitation does not financially obligate the Conference organisers or any of their related partners in any way. All expenses incurred in relation to the Conference are the sole responsibility of the attendee.

Visa Requirements

It is the sole responsibility of the attendee to take care of his/her visa requirements. Attendees who require an entry visa must allow sufficient time for the application procedure. Attendees should contact the nearest embassy or consulate to determine the appropriate timing of their visa applications.

The organisers will not directly contact embassies and consulates on behalf of visa applicants. You can check whether you need a visa to enter Türkiye on the following website: <https://www.mfa.gov.tr/default.en.mfa>

In the event that a visa application is unsuccessful, but was applied for in due time, the registration fee, minus a handling fee of 50 Euro can be refunded. To receive the refund, the official proof from

the embassy confirming that a visa could not be granted, must be sent to the Dioxin 2025 Registration Team no later than 25 October , 2025.

Registration Name Change

A handling fee of 50 Euro will be charged for every name change to an existing Conference registration. A new registration form for the substitute attendee should be submitted, as well as a proof for the reduced fee if applicable. Name changes will only be accepted until the standard registration deadline indicating clearly the new and old name. After the standard registration deadline, all name changes must be carried out on-site.

Lost Name Badge

The name badge must be worn at all times during the Conference. Access to the Conference facilities will not be granted without a proper name badge. If an attendee loses, misplaces or forgets the name badge, a handling fee of 20 Euro will be charged for a new name badge. Upon handing out a new name badge, the lost badge will become invalid.

Registration Cancellation, Transfer & Refund Policy

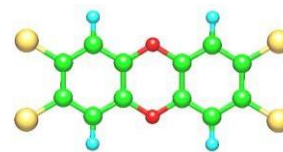
Notification of cancellation must be made in writing and sent to the Thor Events Registration Department by email (dioxin2025@thorevents.com). The notification must include all the relevant information regarding the bank account to which a possible refund may be remitted.

Cancellation & transfers conditions for delegates, exhibitors and visitors:

The following cancellation conditions will apply:

- Until 01 September 2025 for any reason, the full amount will be refunded minus a €100 cancellation fee (excluding applicable VAT and excluding any and all transfer costs which shall be fully borne by the participant)
- Refund requests will be processed after the Conference only and refunds will be made within 30 days from the end of the Event. Refund requests must be made in writing and sent to the Dioxin 2025 Registration Team by email no later than 20 October, 2025. No refund request will be processed after this date.
- From 02 September 2025, refunds are no longer possible, however transfer of registration may be accommodated (see transfers conditions below)

- In case of payment by bank transfer, the notification of cancellation must include the bank details for a possible refund of the registration fee. All bank charges will be charged to delegates.
- Same applies for cancellation of additional orders.
- Credit will not be given for unattended events or early termination of attendance.

Registrations could be transferred following the applicable conditions below:

- Until 20 October 2025: a transfer of registration to another participant from the same company may be accommodated at the discretion of the Organiser for a EURO (€) 50.00 admin fee. Please do reach out to the registration team dioxin2025@thorevents.com who will make this discretionary decision.
- From 20 October 2025: to Congress days: a transfer of registration to another participant from the same company may be accommodated at the discretion of the Organiser for a EURO (€) 50.00 admin fee and only in the case that participant is unwell with COVID-19 or other infection or any other disease (medical certificate would be requested), your country does not allow you to travel, or Türkiye does not allow you entry. You will be expected to provide evidence in these cases.

Cancellation & transfers conditions for Speakers & Moderators:

Exceptionally, due to their crucial role they play in the scientific programme, speakers and moderators will be able to cancel their registrations until 01 October with only a €100 cancellation fee.

As of 02 October, cancellation will be permitted for speakers & moderators in the case that their country has closed its borders, or they have a current COVID-19 infection or any other infection. Proof will be required in each case and the €100 cancellation fee will still apply.

Registrations could be transferred following the applicable conditions below:

- Until the date of the Event speakers & moderators may transfer registration to another participant or speaker or moderator without any cost. All transfer requests must be sent to dioxin2025@thorevents.com.

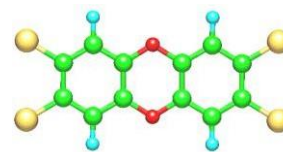
All refunds are made in EURO (€) and are subject to prevailing exchange rates. Refunds will be processed within 30 days from the end of the Event, and in the same manner as the original payment was received. If bank charges apply, they will be deducted from the refunded amount.

Modification of the Conference Programme

The Conference organisers reserve the right to modify the programme, which is published as an indication only.

Modification & Cancellation of the Congress

The Organiser reserves the right to modify the Scientific Programme, which is published as an indication only. In the event of cancellation of the Congress, at any time, as a result of any event of 'force majeure' or for other reasons that are beyond the control of the Organiser, the registration fee shall be refunded minus EURO (€) 50.00 admin fee (excl. applicable VAT and applicable transfer

In case the participant decides to register after having being reimbursed, the new applicable rate may apply.

Use of Material

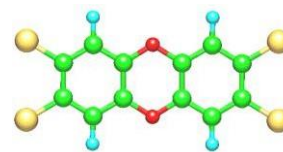

Covid-19 or any other Pandemic Assumption of Risk & Waiver of Liability

You acknowledge that covid-19 has been declared a worldwide pandemic by the world health organization, is extremely contagious and is spread mainly through close contact from person-to-person. You therefore acknowledge and agree that the Organiser or the Venue cannot guarantee that you will not become infected with COVID-19 at the Event or any other type of infections. You understand the risk of becoming exposed to or infected by COVID-19 or any other type of infection in connection with your participation in the Event and you personally assume this risk. Additionally, you forever expressly release and waive all and any claims (whether in contract, tort or otherwise) against the Organiser or the Venue and their respective officers, directors, employees, contractors,

You expressly understand and agree that this waiver means that, to the fullest extent permitted by law, you give up your right to bring any claims, demands, causes of action, or suits including for personal injury, death, disease or property losses, or for any other losses, liabilities, costs and expenses including but not limited to claims of negligence, and give up any claim that you may have to seek damages, whether known or unknown, foreseen or unforeseen.

General Assumption of Risk & Release of Claims

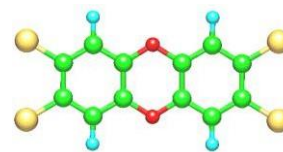

In addition to the COVID-19 or any other pandemic/infections assumption of risk and waiver of liability section of these terms, to the maximum extent permitted under applicable law, you accept and assume all risks of any and all personal injury or damage to your personal property that you may face while attending the event. You hereby release the Organiser, the Venue, and their respective officers, directors, employees, contractors, representatives, agents, licensors, successors and assigns from, and waive, any and all claims, demands, causes of action, suits, damages, losses, liabilities, costs and expenses (including without limitation reasonable attorneys' fees and costs) that you may have now or in the future, whether known or unknown, foreseen or unforeseen, associated in any way with the event.

Liability & Disclaimer

In the case of government intervention or regulation, military activity, strikes or any other circumstances that make it impossible or inadvisable for the Event to take place at the time and place as announced, the participant shall waive any claim for damages or compensation and there shall be no past, present or future liability for either party. The participant acknowledges that he/she has no right to lodge damage claims against the organisers should the holding of the event be hindered or prevented by unexpected political or economic events or generally by force majeure or should the non-appearance of speakers or other reasons necessitate programme changes. With registration, the participant accepts this proviso. The Organiser shall not be deemed responsible for any bodily injury/death or property damages (including theft) sustained by participants during the Event, unless such damages are a direct result of an unlawful act of the Organiser. In any event, the Organiser does not accept liability for damages in the event of bodily injury/death, property damage, disruption to travel plans and costs incurred as a result of force majeure or as a result of any other reason beyond the control of the Organiser.

Force Majeure

Force majeure reasons include but are not limited to war or threat of war, riots, civil strife, terrorist activity, industrial disputes, natural or nuclear disaster, adverse weather conditions, epidemics, pandemics, health risks, fire and closure of airports or airspace, government decisions or administrative injunctions, including without limitation possible restrictions, recommendations, guidelines, or other

measures imposed or recommended to be taken by (health) authorities. It is moreover expressly agreed that the unforeseeability condition does not have to be fulfilled for any health-related event (such as for instance coronavirus related pandemic, another pandemic or epidemic and/or quarantine measures) to qualify as an event of force majeure.

Event Rules & Regulations

Whilst participating in the Event, you are required to comply with any policies or directions (such as but not limited to security, health, and safety regulations) in force at the time of the Event, given by the Organiser or Thor Events or any other relevant third party, including the person responsible for the premises where the Event takes place or any competent authority. In particular, if the Organiser or Thor Events will supply ID badges for security purposes, participants must wear their badge at all times. Badges are strictly personal and may not be transferred to another person, nor modified. The Organiser or Thor Events accept no responsibility for any belongings that participants bring at the Event. Any loss or damage to such belongings is at the participant's own risk.

Data Protection & Privacy Policy

The Turkish Law on the Protection of Personal Data (KVKK) entered into force on 7 April 2016, and it involves some additions to protection of the protection and privacy of Participants. The Organiser and Thor Events (acting as data processor on this event) take your privacy very seriously and perform their activities and services in compliance with KVKK requirements. By registering to the DIOXIN 2025 – running from 1 to 6 November 2025 you consent to the applied privacy policies. Severability Clause

Governing Law

Any dispute resulting from the above terms and conditions will be subject to the law of Belgium, and by accepting these terms you are submitting yourself to the exclusive jurisdiction of the courts of Belgium.

General Disclaimer

Notwithstanding the conditions outlined in this document, the organizer (Thor Events and/or Dioxin2025 Chair) reserves the right to cancel any registration or hotel reservation, request additional payment, or take corrective measures in the event of miscalculations by the online payment system or if reevaluation is deemed necessary.
